### FTSE SMALL CAP - WINNERS

Eukedos rises 7.1 percent to lead the list of small-cap companies. Over the past month, the stock has performed flat while losing 3.0% over the past six months and 20% over the past year.

d'Amico International Shipping gains 6.1%, extending gains of 20% in the last month, 115% in the last six months, and 383% in the last year.

### FTSE SMALL CAP - LOSERS

Banca Sistema gives up 3.9 percent and sits at the bottom of its basket. Banca Sistema's board of directors Friday approved preliminary results for 2022, which closed with a net profit of EUR22.0 million from EUR23.3 million as of Dec. 31, 2021. Net interest income stood at EUR85.4 million, up 4.0 percent from EUR81.9 million in 2021. Net interest and other banking income stands at EUR106 million from EUR108 million the previous year. Capital ratios as of December 31, 2022, up from September 30, 2022, stood at 12.6 percent for CET1 and 15.9 percent for TIER 1 and Total Capital Ratio.
