EXECUTED BUY-BACK PROGRAM

Luxembourg - July 17th, 2023 – d'Amico International Shipping S.A. (following “DIS” or the “Company”) announces today that during the period between July 10th and July 14th, 2023, n. 160,000 own shares (representing 0.129% of the outstanding share capital of the Company) were repurchased on the regulated market managed by Borsa Italiana S.p.A. at the average price of Euro 3.6547 and for a total consideration of Euro 584,750.83.

As at July 14th, 2023, d'Amico International Shipping S.A. holds nr. 2,265,265 own shares, representing 1.83% of its outstanding share capital.

The transactions were made and coordinated by an independent equity broker duly engaged for this purpose, Equita SIM S.p.A., in compliance with the Board of Directors resolution of June 14th, 2023, and under the authorization to purchase own shares approved by DIS Shareholders' extraordinary meeting held on June 13th, 2023 (as reminded by means of a press release issued on June 14th, 2023).
